WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the Project *Subscription of Online Enrollment System at BPSU Central (PR No. CO2021-01-0027)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the advertisement, three (3) suppliers/bidders signified their intention to participate by submitting their letter of intent and bought the bidding documents;

**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG POST
QUALIFICATION EVALUATION REPORT AND DECLARING LCRB**

BAC Resolution No. 005-B Series of 2021

WHEREAS, the Bataan Peninsula State University- Bids and Awards Committee confirmed the TWG Bid Evaluation Report and declare the Single Calculated Bid- **MAROONSTUDIOS INC.**

WHEREAS, on February 23, 2020 the TWG conducted the Post Qualification of the Lowest Calculated Bid in order to determine whether the bidder complies with and is responsive to all the requirement and conditions as specified in the Bidding Documents.

WHEREAS, the TWG verified, validated and ascertained all statements made and documents submitted by the bidder with the Lowest Calculated Bid (LCB), using non-discretionary criteria, the Technical requirements, and Financial requirements;

WHEREAS, upon presentation of the TWG Report on the Post Qualification Evaluation to the BAC, the TWG properly discussed and deliberated the contents of the Report;

WHEREAS, the **Technical Working Group (TWG)** found out that the Lowest Calculated Bid (LCB) - **MAROONSTUDIOS INC.** was not responsive due to the following findings during the post qualification: SLCC provided (Admission of Patients) is not related to online enrollment and they not have proof of an existing online enrollment system for a university/institution of higher learning, as contained in the TWG Post Qualification Evaluation Report and confirmed by the BAC;

WHEREAS, the **Technical Working Group (TWG)** post qualified the second lowest bidder, **PINNACLE TECHNOLOGIES INC.** since the lowest calculated bid wasn't able to meet the minimum requirement.

WHEREAS, upon post qualification the **Technical Working Group (TWG)** encountered problem and concern on the system's flexibility presented by the second lowest bidder thus, **PINNACLE TECHNOLOGIES INC.** was declared post-disqualified by the (TWG);

WHEREAS, the bidder with 3rd LCB, **DIGITAL SOFTWARE TECHNOLOGY CONSULTANCY**, post qualified and complied with all the requirements and further found to be responsive, as contained in the TWG Post Qualification Evaluation Report and confirmed by the BAC;

WHEREAS, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the Project *Subscription of Online Enrollment System at BPSU Central (PR No. CO2021-01-0027)*; posted the same in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University continuously for 7 days.

WHEREAS, in response to the said advertisement ~~three (3)~~ prospective suppliers namely (1) **PINNACLE TECHNOLOGIES INC.**, (2) **MAROONSTUDIOS INC.**, and (3) **DIGITAL SOFTWARE TECHNOLOGY CONSULTANCY** signified their intention to participate by submitting their letter of intent and bought the bidding documents. On the day of the submission and opening of bids, the abovementioned prospective bidders were able to submit their bid proposals and passed the preliminary examinations when the technical eligibility documents were evaluated. Upon post-qualification, **MAROONSTUDIOS INC.**, and **PINNACLE TECHNOLOGIES INC.** was declared post-disqualified they were not able to meet the minimum requirements set by the TWG/End-User Unit. The **Technical Working Group/ End-User Unit** post-qualified and declared the Bid of **DIGITAL SOFTWARE TECHNOLOGY CONSULTANCY**, with the lowest calculated responsive bid.

WHEREAS, the bid **DIGITAL SOFTWARE TECHNOLOGY CONSULTANCY** were found to be substantially complying.
