The **BATAAN PENINSULA STATE UNIVERSITY (BPSU)**, through its **Bids and Award Committee (BAC)** invites all qualified suppliers to bid for the hereunder project.

Name of Project:

PR No. DC2022-03-025-Improvement of Façade of Business Center and ICT Building at BPSU-Dinalupihan Campus (complete details and specifications shall be included in the official bidding documents and can be viewed at the PhilGEPS). Approved Budget for this contract – Four Million Two Hundred Sixty-four Thousand Three Hundred Fifteen pesos and 13/100 only (Php 4,264,315.13).

Prospective bidders should have experienced undertaking similar projects within the last three (3) years amounting to at least 50% of the proposed project for bidding. Eligibility check as well as the preliminary examination of bids shall use non-discretionary "pass/fail" criteria. Post qualification of the lowest calculated bids shall be conducted. All Bids in excess of the Approved Budget for the Contract shall automatically be rejected at Bid Opening.

All particulars relative to Eligibility Statement and Screenings, Bid Security, Performance Security, Prebid Conferences, Evaluation of Bids, Post Qualification and Award of Contract shall be governed by the pertinent provision of R.A. 9184 and its revised I.R.R.
