**BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG DETAILED BID
EVALUATION REPORT AND DECLARING THE LOWEST CALCULATED BID (LCB)
AND RECOMMENDING FURTHER FOR POST QUALIFICATION**

BAC Resolution No. 23-A Series of 2022

WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the project *Flooring Improvement of Academic Building I and P.E. Building with Additional Sink at BPSU Dinalupihan Campus (DC2022-05-036)* in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, five (3) *prospective bidders*, namely: (1) *Five A Construction*, (2) *D.M. Madarang Construction*, and (3) *MECCON Systems Services & Maintenance Product* signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference, which was held on July 15, 2022;

WHEREAS, abovementioned bidders pursued in joining the project by purchasing the bidding documents and submitting their bid proposals together with another two bidders namely, (1) *AJA Builders*, and (2) *M.J. Camacho Construction*, prior to the deadline on August 2, 2022. When the bid proposals were evaluated, out of *five (5) bidders* only *two of them* passed on the preliminary detailed bid evaluation that was conducted during the bid opening;

2. D.M. MADARANG CONSTRUCTION	Php 2,236,648.53	2 nd Lowest Calculated Bid (2 nd LCB)
3. MECCON SYSTEMS SERVICES & MAINTENANCE PRODUCT	N/A	DISQUALIFIED -failed to comply with the minimum requirement on the key personnel. Safety Officer is not qualified.
4. AJA BUILDERS	N/A	DISQUALIFIED -failure to meet SLCC requirement, which must be similar to the project and within the last three (3) years from the date of submission and receipt of bids.
5. M.J. CAMACHO CONSTRUCTION	Php 2,182,090.00	Lowest Calculated Bid (LCB)

WHEREAS, the Technical Working Group (TWG) declared the Bid of **M.J. CAMACHO CONSTRUCTION (LCB)**;

- To recommend further that the TWG will conduct the Post- qualification on the bidder with Lowest Calculated Bid (LCB) – **M.J. CAMACHO CONSTRUCTION** and the bidder with LCB to prepare additional post qualification document pursuant to Section 34.2 on the 2016 Revised Implementing Rules and Regulation of the RA 9184.

WHEREAS, the TWG verified, validated and ascertained all statements made and documents submitted by the bidder with the Lowest Calculated Bid (LCB), using non-discretionary criteria, the Technical requirements, and Financial requirements;

WHEREAS, upon presentation of the TWG Report on the Post Qualification Evaluation to the BAC, the TWG properly discussed and deliberated the contents of the Report;

WHEREAS, the **Technical Working Group (TWG)** found out that the Lowest Calculated Bid (LCB) **M.J. CAMACHO CONSTRUCTION** as non-responsive and non-compliant due to misrepresentation of Master Plumber PRC license and the bid offered submitted did not include any of the items that were included in the bid bulletin, as contained in the TWG Post Qualification Evaluation Report and confirmed by the BAC;

WHEREAS, the **Technical Working Group (TWG)** post-qualified the second lowest calculated bidder – **D.M. MADARANG CONSTRUCTION** and found to be responsive with all the minimum requirements, as contained in the TWG Post Qualification Evaluation Report and confirmed by the BAC;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

BAC RESOLUTION DECLARING THE LOWEST CALCULATED RESPONSIVE BID

BAC Resolution No. 23-C Series of 2022

WHEREAS, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the Project *Flooring Improvement of Academic Building I and P.E. Building with Additional Sink at BPSU Dinalupihan Campus (DC2022-05-036)*; posted the same in the Bataan Peninsula State University website, PhilGEPS and a conspicuous place at the premises of the Bataan Peninsula State University.

WHEREAS, in response to the said advertisement, five (3) *prospective bidders* namely, (1) *Five A Construction*, (2) *D.M. Madarang Construction*, and (3) *MECCON Systems Services & Maintenance Product* signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference, which was held on July 15, 2022;. The abovementioned bidders pursued in joining the procurement activity by purchasing the bidding documents and submitting their bid proposals together with another two bidders namely, (1) *AJA Builders*, and (2) *M.J. Camacho Construction*, prior to the deadline on August 2, 2022. When the bid proposals were evaluated, out of five (5) bidders only two of them passed on the preliminary detailed bid evaluation that was conducted during the bid opening. The **Technical Working Group (TWG)** declared the Bid of **M.J. CAMACHO CONSTRUCTION** as the **Lowest Calculated Bid (LCB)**. However, the bidder with LCB was declared POST-DISQUALIFIED due to misrepresentation of Master Plumber PRC license and the bid offered submitted did not include any of the items that were included in the bid bulletin which are clearly non-compliance to the minimum requirement.

WHEREAS, the TWG post-qualified the 2nd LCB on August 12 to 15, 2022 and found the bid of **D.M. MADARANG CONSTRUCTION** to be substantially complying;
