BAC RESOLUTION ADOPTING AND CONFIRMING THE TWG DETAILED BID EVALUATION REPORT AND DECLARING THE SINGLE CALCULATED BID (SCB) AND RECOMMENDING FURTHER FOR POST QUALIFICATION

BAC Resolution No. 36-A Series of 2022

WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the project *Construction of Dormitory (Ladies) at BPSU Abucay Campus (PR No. AC2022-10-299)* in the Bataan Peninsula State University website, PhilGEPS and in a conspicuous place at the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, *seven (7)* prospective bidders signified their intention to participate by submitting a letter of intent. All of them, namely: *(1) Bonibal Construction, (2) CJ Oliva Construction, (3) S.M. Castro Management & Construction Services, (4) RUCS Konsult & Construction Services, (5) RM Mangubat Construction, (6) D-Map, and (7) DMA*, joined the Pre-bid Conference on October 19, 2022;

WHEREAS, none of them pursued in joining the project. Two (2) bidders, *DM Madarang Construction and RZ Tigas Construction and Trading*, purchased bidding documents and submitted its bid proposal prior to the deadline. When the bid proposals were evaluated, only DM Madarang Construction passed the preliminary detailed bid evaluation that was conducted during the bid opening;

WHEREAS, the Bataan Peninsula State University advertised the Invitation to Apply for Eligibility and To Bid of the Project *Construction of Dormitory (Ladies) at BPSU Abucay Campus (PR No. AC2022-10-299)*; posted the same in the Bataan Peninsula State University website, PhilGEPS and in a conspicuous place at the premises of the Bataan Peninsula State University continuously for 7 days;
