WHEREAS, the Bataan Peninsula State University through its Bids and Awards Committee (hereinafter referred to as BAC) posted an invitation to bid for the project *Subscription of Online Enrollment System for Academic Year 2022-2023 at BPSU Central Office (C02022-07-0417)* at the Bataan Peninsula State University website, PhilGEPS and in a conspicuous place inside the premises of the Bataan Peninsula State University;

WHEREAS, in response to the said advertisement, three (3) *prospective bidders*, namely: (1) *My Busybee Inc.*, (2) *Abakada Studios*, and (3) *Digital Software Technology Consultancy* signified their intention to participate by submitting a letter of intent and joining the Pre-bid Conference, which was held last August 3, 2022;

WHEREAS, the abovementioned bidders, except for *My Busybee Inc.*, pursued joining the project by purchasing the bidding documents and submitting their bid proposals together with another bidder, namely, *AVTECH Information Technology Solutions, Inc.*, prior to the deadline on August 15, 2022. When the bid proposals were evaluated, out of three (3) *bidders*, *only one of them* passed the preliminary detailed bid evaluation that was conducted during the bid opening;

And with no other attachment that is relevant period or delivery date when the said SLCC was completed;

WHEREAS, the Technical Working Group (TWG) declared the Bid of **DIGITAL SOFTWARE TECHNOLOGY CONSULTANCY** as *Single bid as read* since the other bidders were disqualified;

- To recommend further that the TWG will conduct the Post- qualification on the bidder with Single Calculated Bid (LCB) – **DIGITAL SOFTWARE TECHNOLOGY CONSULTANCY** and the bidder with SCB to prepare additional post qualification document pursuant to Section 34.2 on the 2016 Revised Implementing Rules and Regulation of the RA 9184.
