INVITATION TO BID

PR no. MCO2023-11-1115– Supply and Delivery of Appreciation Package for Bataan Peninsula State University (BPSU) Employees

1. The Bataan Peninsula State University, through the Retained Income Fund (RIF) and General Appropriation Act (GAA) intends to apply the sum of Two Million Two Hundred Thousand Pesos only (Php 2,400,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for – Supply and Delivery of Appreciation Package for Bataan Peninsula State University (BPSU) Employees. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Bataan Peninsula State University now invites bids for the above Procurement Project. Completion of the project is required by seven (7) calendar days upon receipt of the Notice to Proceed (NTP). Bidders should have completed, within the last three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from Bataan Peninsula State University and inspect the Bidding Documents at the address given below during 8:00AM to 5:00PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on December 15, 2023 from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five thousand pesos (Php5,000.00) for 1 Lot (total). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or electronic means.

6. The Bataan Peninsula State University will hold a Pre-Bid Conference on December 27, 2023 2:00 PM at the Board Room 2nd Floor of Admin. Bldg., BPSU Main Campus, Capitol Compound, City of Balanga, Bataan, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission (in person or via courier) at the office of the BAC Secretariat, BPSU Main Campus, Capitol Compound, City of Balanga, Bataan on or before January 8, 2024 at 9:00 AM. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on January 8, 2024 at 10:00 AM at the Board Rm., 2nd Floor of Admin. Bldg. BPSU Main Campus, Capitol Compound, City of Balanga, Bataan. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. a. Payment of the applicable fee for the Bidding Documents can be deposited to:

A letter of intent should be emailed first to bac@bpsu.edu.ph, after which a confirmation letter will be sent to the prospective bidder's email address before payment can be made. A copy of the deposit slip should be emailed to the BAC for verification. Payment through bank transaction is due until 4pm of January 5, 2024 or the day before the scheduled opening of bids, while personal payment can be made until 8:30am of January 8, 2024 prior to the submission and opening of bids.

b. Each Bidder shall submit one (1) copy (marked ORIGINAL BID) of the first and second components of its bid. Moreover, the Procuring Entity requests for three (3) additional hard copies of the Original Bid (marked Copy 1, Copy 2 and Copy 3).

11. The Bataan Peninsula State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
