- 1. The Bataan Peninsula State University, through the Custodial Fund- DOST-PCIEERD- BPSU Sikat TBI intends to apply the sum of One Million Four Hundred Ninety-Six Thousand Six Hundred Fifteen Pesos and Eighty-Four Centavos only (Php 1,496,615.84) being the Approved Budget for the Contract (ABC) to payments under the contract for Refurbishment of Chemistry Lecture Room at Main Campus (PR No. MCO2023-11-1022). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Bataan Peninsula State University now invites bids for the above Procurement Project. Completion of the Works is required for One Hundred Twenty (120) calendar days upon the commencement date indicated in the Notice to Proceed (NTP). Bidders should have completed a contract similar to the Project within the last three (3) years from the date of submission and receipt of bids. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
- 4. Interested bidders may obtain further information from Bataan Peninsula State University and inspect the Bidding

Documents at the address given below from 8:00AM to 5:00PM.

- 5. A complete set of Bidding Documents may be acquired by interested bidders on January 5, 2024 from given address and website below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5, 000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees either in person or through electronic means.
- 6. The Bataan Peninsula State University will hold a Pre-Bid Conference on January 15, 2024, 10:00am at the Board Rm, 2nd floor, Admin Bldg., BPSU Main Campus, Capitol Compound, City of Balanga, Bataan and/or through videoconferencing/webcasting via Google Meet, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission (in person or via courier) at the office address as indicated below on January 29, 2024 up to 9:00am. Late bids shall not be accepted.
- 8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
- 9. Bid opening shall be on January 29, 2024, 10:00am at the Board Rm, 2nd floor, Admin Bldg., BPSU Main Campus, Capitol Compound, City of Balanga, Bataan and/or through Google Meet. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

A letter of intent should be emailed first to bac@bpsu.edu.ph, after which a confirmation letter will be sent to the prospective bidder's email address before payment can be made. A copy of the deposit slip should be emailed to the BAC for verification. Payment through bank transaction is due until 4pm of January 26, 2024 or the day before the scheduled opening of bids, while personal payment can be made until 8:30am of January 29, 2024 prior to the opening of bids.

- b. Each Bidder shall submit one (1) copy (marked ORIGINAL BID) of the first and second components of its bid. Moreover, the Procuring Entity requests for three (3) additional hard copies of the Original Bid (marked Copy 1, Copy 2 and Copy 3).
- 11. The Bataan Peninsula State University reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
